ORDER

The Writ Petition has been filed to direct the respondent authority to give Bandhobasth and permission for conducting the Cultural dance program (Adal Padal) in the event of Thotti Palayam Village Sri Bhagavathi Amman & Mariamman Kovil on 26.01.2023 between 6 pm to 11 pm based on the petitioner's representation dated 04.01.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 26.01.2023 between 06:00 pm to 11:00, conducting the Cultural dance program (Adal Padal) in the event of Thotti Palayam Village Sri Bhagavathi Amman & Mariamman Kovil, the petitioner has sent a representation, dated 04.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (crl.side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 04.01.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
