No. 164/ 4A1B1 and 164/ 4A1D 164/4A1F in Krishnapuram Village of Udumalpet Taluk in Tiruppur District as per Sale Deed dated 19.07.2000 registered as Doc. No. 3044/ 2000 on the file of Sub Registrar Udumalpet and issue a separate subdivision and patta for his name by considering the petitioners application dated 29.04.2022.
