Mr.G.Baskaran, learned Central Government Standing Counsel appearing on behalf of the respondents would submit that the SLP filed by the respondent Postal Department in SLP No.25515 of 2010 came to be dismissed by the Hon'ble Supreme Court vide its order dated 25.05.2022. The respondent Postal Department also reinstated the petitioner back into service and complied
