2. The petitioners are the elected ward member. They have made a representation to the District Collector, Tiruppur to take action against the President of Panchayat Board under Section 205 of the Tamil Nadu Village Panchayat Act for the alleged irregularities. Since the representation was pending this Writ Petition has been filed for a direction to dispose of the representation on merits.

3. The sum and substance of the representation are to the effect that the representation sent by them, as the ward members of the Panchayat against the Panchayat President for initiation of the action on the ground that Panchayat President is granting building plan approval, before the Panchayat passing any resolution.

The learned Special Government Pleader produced a copy of the proceedings by the first respondent/District Collector and submitted that action has been initiated on the representation and show cause notice has been issued to the District Development Officer and also the Village Tahsildar, Tharapuram and further actions will be taken in
