Prayer: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus, calling for the records on the file of the first respondent bearing No.ENG/32/2010 dated 22.03.2010 read with the order bearing No.Sa.Je.Thi/J/P269/V/ Sub. Helper II/C&W/Loco/Vol dated 11.10.2010 issued by the second respondent, quash the same as illegal to the extent the petitioner is reengaged as a Substitute Helper and granted temporary status with

effect from 19.09.2010 and consequently direct the respondents to reinstate the petitioner with continuity of service from 31.12.97 and grant him all consequential benefits including temporary status, permanency, re-fixation of pay scale, arrears of salary, seniority, with payment of 50% backwages and all other attendant benefits with exemplary costs.
