ORDER

2. Heard the learned counsel appearing for the respondents and perused the materials available on record.

3. The learned counsel appearing for the respondents submitted that the petitioner union has challenged the promotion policy of the year 2012. As per the policy, the period of the policy shall be in force only for a period of three years i.e., from 01.04.2012 and the same had come to an end on 01.04.2015. Hence, the prayer sought in this writ petition has become infructuous.

4. Accordingly, this writ petition is dismissed as having become infructuous. No costs. Consequently connected miscellaneous petitions are also closed.
