PRAYER: Writ Petition filed under Article 226 of the Constitution of India, to issue a writ of certiorarified mandamus calling for the records relating to the order passed by the 1st respondent in Na.Ka.No.2/28419/2007 Ni.A. Dated 09.01.2010 rejecting the petitioner's request to consider the period between 18.06.2002 and 27.09.2002 as compulsory wait period and



quash the same as illegal and consequently to direct the first respondent to treat the said period as compulsory wait period and confer all service benefits in the light of the recommendations of the second respondent dated 02.07.2002, 30.07.2002 and 14.08.2002.

ORDER
