Prayer:

Plaint filed under Order VII Rule 1 of the CPC, 1908 read with Order IV Rule 1 of the Original Side, 1957 praying for a judgment and decree as follows:-

a) Removing Defendants 1 to 8 from Chennai Vazhal Duraiyur Nadar Uravin Murai Magami Sangam at No.80, S.R.P. Koil Street, Agaram, Chennai – 82.

b) Directing the defendants to deliver the possession of the land and building at Door No.80, S.R.P. Koil Street, Agaram, Chennai – 82 to the 1st plaintiff and its members;
