This Writ Petition has been filed to direct the respondents to consider the petitioner's representation dated 02.01.2023 and take necessary action including inspection of the premises of the petitioner and remove the stray dogs from the premises.

The case of the petitioners is that the stray dogs residing within the premises of the petitioner's apartment are causing severe nuisance and havoc among the apartment owners by damaging the vehicles and in fact few residents have even met with bike accidents due to the stray dogs chasing them. The stray dogs are also attacking and chasing residents causing huge havoc and the children and elders of the apartments are unable to stroll through the corridors and parks fearing attack from the said dogs.
