2. The case of the petitioner is that the he is the owner of the subject property. The grievance of the petitioner is that he had made a representation to the respondents on 07.09.2022 and a reminder representation on 03.01.2023, seeking to measure his land and fix the boundary stones for his subject property, which are pending without consideration till date. Hence, this petition.

3. The learned Special Government Pleader fairly submitted that the petitioner has not made an online application seeking for measuring and fixing the boundaries, if the same is made by paying requisite fees, the application

Such exercise shall be completed within a period of three months from the date of filing of online application.
