ORDER

The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Kottivakkam Kuppam Arulmigu Sree Muthalamman Temple Festival at Sholinganallur Taluk, Chengalpattu District on 05.02.2023 between 06.00 pm to 11.00 pm by considering the petitioner's representation dated 15.01.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 05.02.2023, from 6.00 p.m. to 11.00 p.m., in the Temple Festival of Kottivakkam Kuppam Arulmigu Sree Muthalamman Temple Festival at Sholinganallur Taluk, Chengalpattu District, the petitioner has sent a representation, dated 15.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (crl.side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

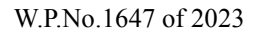
4. I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (crl.side) appearing for the respondent police.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 15.01.2023 and pass suitable orders based on the above said circular.
