ORDER

The Writ Petition has been filed to direct respondent authority to give permission to conduct cultural programme (Adal Padal) at Salem District, Pethanaickenpalayam Taluk, Oddapatti Village, Sri Siva Subramaniya Swamy, Sri Arthanareeswarar Thiru Kovil Festival on 21.01.2023 by considering petitioner's representation dated 05.01.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Pethanaickenpalayam Taluk, Oddapatti Village, Sri Siva Subramaniya Swamy, Sri Arthanareeswarar Thiru Kovil Festival on 21.01.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 05.01.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 05.01.2023 and pass suitable orders based on the above said circular.
