ORDER

2. The Writ Petition challenges Notice No. TIIC/VPM/LAO/2017-18 dated 19.02.2018 sent by the Second Respondent to the Petitioner regarding the proposed tender-cum-public auction of his assets on 21.03.2018 for failure to repayment of the dues owed by him.

3. This Court at the time of admission on 16.03.2018 had granted interim stay of the impugned proceedings, which was extended by another order dated 16.11.2018 and continues to be in force as on date.
