The Writ Petition has been filed to direct the respondent authority to give permission and police protection to conduct the Cultural programme (Adal Padal Nigalchi) in the event of Ammavasaipalayam Village Arulmigu Sree Balamurugan Temple Festival at Thiruvennainallur Taluk, Villupuram District on 04.02.2023 between 6 PM to 11 PM by considering the petitioner's representation dated 19.01.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Ammavasaipalayam Village Arulmigu Sree Balamurugan Temple Festival at Thiruvennainallur Taluk, Villupuram District on 04.02.2023 between 6PM to 11 PM, the petitioner has sent a representation dated 19.01.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 19.01.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
