The Writ Petition has been filed to direct the respondent authority to give permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of Elumathur Village, Avalur Arulmigu Sree Bhavathi Amman Temple Festival at Modakurichi Taluk, Erode District on 30.01.2023 between 6 PM to 11 PM by considering the petitioner's representation dated 20.01.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 20.01.2023 and pass suitable orders based on the above said circular.
