The Writ Petition has been filed directing the respondent to give for permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of Nangavalli Kattu Valavu Arulmigu Sri Kakkuvan Mariamman Koil at Mettur, Salem – 636 454 on 02.02.2023 between 6 PM to 11 PM based on the petitioners representation dated 16.12.2022.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 02.02.2023, from 6.00 p.m. to 11.00 p.m., in Nangavalli Kattu Valavu Arulmigu Sri Kakkuvan Mariamman Koil at Mettur, Salem – 636 454, the petitioner has sent a representation, dated 16.12.2022 to the respondent.
