ORDER

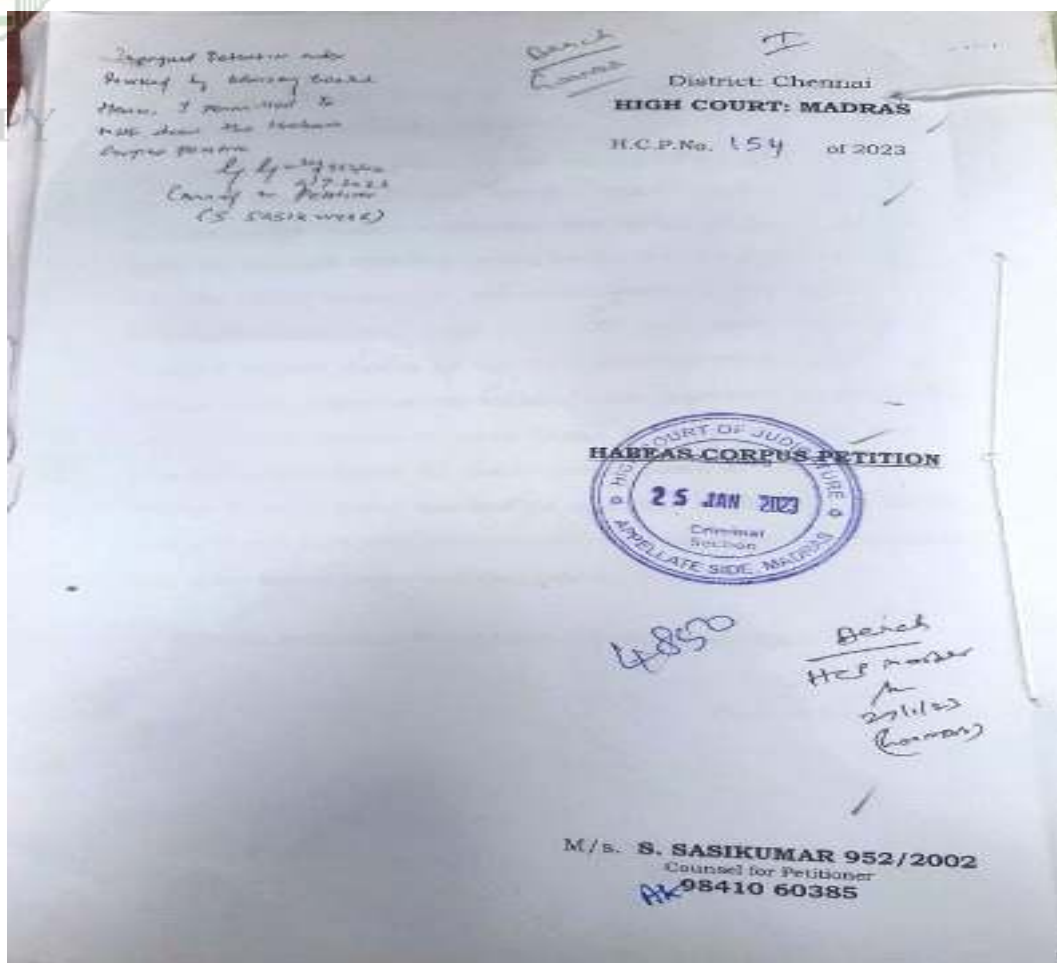
[Order of the Court was made by M.SUNDAR, J.]
