This Transfer Petition is filed seeking to withdraw the FCOP.No.73 of 2022 from the file of Family Court, Ariyalur and transfer the same to the Family Court, Chengalpattu.

2. It is submitted by the learned counsel for the petitioner, who is the wife of the respondent that FCOP.No.73 of 2022 has been filed by the respondent seeking divorce. It is further submitted that both the petitioner and the respondent are working as Software Engineers and are stationed at Chennai.
