COMMON ORDER

The writ petitions has been filed challenging the award dated 22.01.2010 passed by the second respondent viz., the III Additional Labour Court, Chennai, in I.D.No.312 of 2008, thereby directed the Management to reinstate the first respondent/workman into service with continuity of service, backwages and all attended benefits.

2. The Contempt Petition has been filed to punish the Management for non compliance of the order dated 17.06.2010, passed by this Court in M.P.No.1 of 2012 in W.P.No.12599 of 2010, thereby granting interim stay of the award dated 22.01.2010, on condition that the Management shall pay wages under Section 17-B of the Industrial Dispute Act to the workman.

3. When the matter is taken up for hearing, the learned Senior Counsel appearing for the Management submitted that the matter has been settled out of Court. Further in the contempt petition, the order passed by this Court is also complied with.

4. Recording the above submission, the Writ Petition and the Contempt Petition are closed. Consequently, connected miscellaneous petition is also closed. There shall be no order as to cost.
