WEB COPY The Writ Petition has been filed directing the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Thiruvagoundanur Village Arulmigu Sree Mariyamman Temple Festival at Salem Taluk & District on 04.02.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 20.01.2023.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 04.02.2023, from 6.00 p.m. to 11.00 p.m., in the event of Thiruvagoundanur Village Arulmigu Sree Mariyamman Temple Festival at Salem Taluk & District on 04.02.2023, the petitioner has sent a representation dated 20.01.2023 to the respondent.
