ORDER

The Writ Petition has been filed directing the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 04.02.2023 at 06.00 PM to 11.00 PM at “Sri Periyandichiamman Temple Festival” Kazhanikattur Village, Nagarkoodal Post, Nallampalli Taluk, Dharmapuri District by considering and passing orders on the representation dated 24.01.2023 made by the petitioner.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 04.02.2023, from 6.00 p.m. to 11.00 p.m., in the event of “Sri Periyandichiamman Temple Festival” Kazhanikattur Village, Nagarkoodal Post, Nallampalli Taluk, Dharmapuri District, the petitioner has sent a representation, dated 24.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.
