ORDER

The Writ Petition has been filed, directing the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 09.02.2023 at 06.00 PM to 11.00 PM at “Sri Periya Mariamman Temple Festival” Thirumalaigiri Village, Thirumalaigiri Post, Salem Taluk, Salem District by considering and passing orders on the representation dated 24.01.2023 made by the petitioner.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 09.02.2023, from 6.00 p.m. to 11.00 p.m., in the event of “Sri Periya Mariamman Temple Festival” Thirumalaigiri Village, Thirumalaigiri Post, Salem Taluk, Salem District the petitioner has sent a representation dated 24.01.2023 to the respondents.
