ORDER

The Writ Petition has been filed to direct the respondent and to grant permission to conduct the cultural programme of Adal Padal on 02.02.2023 at 06.00 PM to 11.00 PM at “Sri Omkalamman Temple Festival” Nangavalli Village, Nangavalli Post, Mettur Taluk, Salem District by consider and pass orders on the representation dated 24.01.2023.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 02.02.2023, from 6.00 p.m. to 11.00 p.m., “Sri Omkalamman Temple Festival” Nangavalli Village, Nangavalli Post, Mettur Taluk, Salem District, the petitioner has sent a representation dated 24.01.2023 to the respondent.
