ORDER

The Writ Petition has been filed directing the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) at Velanatham Village, Pavadi in the event of Velanathan Village Arulmigu Sree Puthu Mariyamman Temple Maha Kumbabishekam Festival at Salem Taluk and District on 03.02.2023 between 06.00 PM to 11.00 PM.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 03.02.2023, from 6.00 p.m. to 11.00 p.m., in the event of Velanathan Village Arulmigu Sree Puthu Mariyamman Temple Maha Kumbabishekam Festival at Salem Taluk and District on 03.02.2023, the petitioner has sent a representation, dated 22.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. Learned Government Advocate (Crl.Side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
