ORDER

The Writ Petition has been filed directing the respondent to give permission to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Mansurabath Village Arulmigu Sree Ramalingeswarar Temple Festival at Chethupattu Taluk, Tiruvannamalai District on 06.02.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 22.01.2023.
