ORDER

The Writ Petition has been filed directing the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Nachipatti Village Arulmigu Sree Pasubathi Amman Temple Festival at Rasipuram Taluk, Namakkal District on 09.03.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 22.01.2023.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 09.03.2023, from 6.00 p.m. to 11.00 p.m., in the event of Nachipatti Village Arulmigu Sree Pasubathi Amman Temple Festival at Rasipuram Taluk, Namakkal District, the petitioner has sent a representation, dated 22.01.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. Learned Government Advocate (Crl.Side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
