ORDER

WEB COPY The Writ Petition has been filed directing the respondent to give permission and police protection to conduct Cultural programme (Adal Padal Nigalchi) in the event of Echampallam Village Arulmigu Sree Sappugundu Muniyappan Temple Festival at Palakkodu Taluk, Dharmapuri District on 15.02.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 24.01.2023.

2. Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 15.02.2023, from 6.00 p.m. to 11.00 p.m., Echampallam Village Arulmigu Sree Sappugundu Muniyappan Temple Festival at Palakkodu Taluk, Dharmapuri, the petitioner has sent a representation, dated 24.01.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. Learned Government Advocate (Crl.Side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 24.01.2023 and pass suitable orders based on the above said circular.
