ORDER

The Writ Petition has been filed directing the respondent to grant permission and police protection to conduct the cultural event viz., Adal Padal (Song and Dance) program to be held on 05.02.2023 at 06.00 PM onwards in connection with the temple festival of Arulmigu Sri Ponmalai Andavar Temple, Kondaiyambalaiyam Village, Nambiyur Taluk, Erode District by considering the petitioner's representation dated 27.01.2023.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 05.02.2023, from 6.00 p.m. to 11.00 p.m., in the event of Arulmigu Sri Ponmalai Andavar Temple, Kondaiyambalaiyam Village, Nambiyur Taluk, Erode District, the petitioner has sent a representation, dated 27.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. Learned Government Advocate (Crl.Side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
