ORDER

The Writ Petition has been filed directing the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Thumbathulipatti Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Salem Taluk and District on 03.02.2023 between 06.00 PM to 11.00 PM by considering the petitioners representation dated 26.01.2023.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 03.02.2023, from 6.00 p.m. to 11.00 p.m., in the event of Thumbathulipatti Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Salem Taluk and District on 03.02.2023, the petitioner has sent a representation, dated 26.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.
