ORDER

The Writ Petition has been filed directing the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Vadugapatti Village Arulmigu Sree Ondi Viraiyan Temple Kumbabishekam Festival at Mohanur Taluk, Namakkal District on 01.02.2023 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 21.01.2023.

2. Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 01.02.2023, from 6.00 p.m. to 11.00 p.m., in the event of Vadugapatti Village Arulmigu Sree Ondi Viraiyan Temple Kumbabishekam Festival at Mohanur Taluk, Namakkal District, the petitioner has sent a representation, dated 21.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. Learned Government Advocate (Crl.Side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
