2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Kalarampatti, Nethaji Street Arulmigu Sree Mariyamman & Kaliyamman Temple Festival at Salem Taluk & District on 12.02.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 24.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
