The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Elangalapatti Village Arulmighu Sri Muniappan Koil at

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 16.12.2022 and pass suitable orders based on the above said circular.
