ORDER

The Writ Petition has been filed seeking to direct the respondent to give permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Arulmigu Sree Angala Parameswariyamman Temple Festival at Vadukkupatti Village, Vaniyambadi Taluk, Tirupathur District on 19.02.2023, between 06.00 p.m. and 11.00 p.m., by considering the petitioner's representation dated 27.01.2023.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 19.02.2023, from 6.00 p.m. to 11.00 p.m., in connection with the Festival of Arulmigu Sree Angala Parameswariyamman Temple at Vadukkupatti Village, Vaniyambadi Taluk, Tirupathur District, the petitioner has sent a representation dated 27.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. Learned Government Advocate (Crl.Side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
