Writ Petition filed under Article 226 of Constitution of India, praying for issuance of Writ of Mandamus directing the respondents to regularize the service of the petitioner with seniority, monetary and all other consequential benefits.

### **ORDER**

This writ petition has been filed to direct the respondents to regularize the service of the petitioner with seniority, monetary and all other consequential benefits.

2. When the matter was taken up for hearing, learned counsel



appearing for the respondents has filed a Memo dated 01.06.2023 stating that the respondent/Management viz., Air India Limited has been taken over by M/s. Talace Private Limited. Hence, this writ petition is not maintainable.

3. In support of the same, learned counsel appearing for the respondents placed reliance in the decision of this Court in ***W.P.No.2910 of 2015 dated 09.03.2023***, which held that the writ petition is not maintainable. For better appreciation the relevant portion of the said order is extracted hereunder:

*“When the matter is taken up, learned counsel for the respondents submitted that they filed memo 08.06.2022 stating that pursuant to the policy decision taken by the Government of India to disinvest 100% share holding of the Government in Air India Limited, M/s Talace Pvt Ltd was declared as successful bidder to buy 100% shares held by it in Air India Limited. Thus Air India Limited ceased to be a Government Company and is a Private Limited Company. Therefore, Air India Limited is not a State within the meaning of the Article 12 of the Constitution of India.*

*5. In view of the above submission, liberty is granted to the petitioner to work out his remedy before the appropriate forum, in which case the time spent in pursuing this writ petition shall stand excluded in reckoning the period of limitation if*

4. In view of the fact that the Government of India ceased to be a share holder, the Air India Limited is ceased to be a State under Article 12 of the Constitution of India. Thus, no writ is maintainable. The petitioner is at liberty to approach the competent forum for redressal of his grievances in the manner known to law, in which case the time spent in pursuing this writ petition shall stand excluded in reckoning the period of limitation if any.

5. Accordingly, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petitions are also closed.
