ORDER

The Writ Petition has been filed to seeking direct the respondents to give permission and police protection to conduct Cultural Programme (Adal Padal) in the event of A.Sappanipatti Village Sri Mariamman & Sri Kamachiamman Temple Festival at A.Sappanipatti Post, Karimangalam Taluk, Dharmapuri District on 08.02.2023, between 06.00 p.m. and 11.00p.m., by considering the petitioner's representation dated 30.01.2023.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 08.02.2023, from 6.00 p.m. to 11.00 p.m., in connection with the Festival of A.Sappanipatti Village Sri Mariamman & Sri Kamachiamman Temple at A.Sappanipatti Post, Karimangalam Taluk, Dharmapuri District, the petitioner has sent a representation dated 30.01.2023 to the second respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. Learned Government Advocate (Crl.Side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

4. I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondent police.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a circular memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 30.01.2023 and pass suitable orders based on the above said circular.
