ORDER

The Writ Petition has been filed seeking to direct the respondents to give permission and police protection to conduct Cultural Programme (Adal Padal) in the event of Sri Kaliamman Temple Festival at Minnur Village, Minnur Post, Ambur Taluk, Tiruppattur District on 22.02.2023, between 06.00 p.m. and 11.00p.m., by considering the petitioner's representation dated 30.01.2023.

Learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 22.02.2023, from 6.00 p.m. to 11.00 p.m., in connection with the Festival of Sri Kaliamman Temple at Minnur Village, Minnur Post, Ambur Taluk, Tiruppattur District, the petitioner has sent a representation dated 30.01.2023 to the second respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 30.01.2023 and pass suitable orders based on the above said circular.
