The Writ Petition has been filed to direct the respondent to give permission to conduct the cultural programme (Adal Padal Nigalchi) in the

event of Thalikottai Colony Arulmighu Sri Sakthi Murugan Koil at Karuvakkurichi, Mannarkudi Taluk, Thiruvarur District on 05.02.2023 between 6 PM to 11 PM based on the petitioner's representation dated 27.01.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Thalikottai Colony Arulmighu Sri Sakthi Murugan Koil at Karuvakkurichi, Mannarkudi Taluk, Thiruvarur District on 05.02.2023 between 06.00 PM to 11.00 PM, the petitioner has sent a representation dated 27.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
