3. Being satisfied with the reasons shown in the affidavit filed in support of the petition, this Court is of the view that the prayer sought for by the petitioner deserves to be considered favourably.

In view of the above, the condition imposed on the petitioner in Crl.M.P.No.407 of 2023 by an order dated 31.01.2023 , is modified to the effect that No.5(i) the petitioner is ordered to be enlarged on bail on his executing a bond for Rs.10,000/-(Rupees Ten Thousand only) with two sureties for a like sum each to the satisfaction of the judicial Magistrate No.6, Coimbatore.
