ORDER

The Writ Petition has been filed to direct the respondent to consider the petitioner's representation dated 19.01.2023 and grant permission to the petitioner in order to conduct the cultural program (Adal Padal Nigalchi) which is scheduled to be held on 21.02.2023 at 6 PM to 11 PM in Sri Angala Amman Temple Mayanakollai festival situated at Ambedkar Street, Virudhampattu, Vellore District – 632 006.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 19.01.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
