ORDER

The Writ Petition has been filed to direct the first and second respondents to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Mariamman Temple festival” Kandampatti Village, Suramangalam Post, Salem Taluk, Salem District on 11.02.2023 at 06.00 p.m. to 11.00 p.m., by considering the petitioner's representation dated 03.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Mariamman Temple festival” Kandampatti Village, Suramangalam Post, Salem Taluk, Salem District on 11.02.2023, the petitioner has sent a representation dated 03.02.2023 to the respondents. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondents submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 03.02.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
