The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Pattanam Muniyappampalayam Village Arulmiugu Sree Maiyamman Temple Festival at Rasipuram Taluk, Namakkal District on 02.03.2023 between 6 PM to 11 PM by considering the petitioner's representation dated 02.02.2023.
