The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct the Cultural programme (Adal Padal Nigalchi) in the event of Veiyappamalai Arulmigu Sree Subramaniya Swamy Temple Panguni Uthiram Car Festival at Tiruchengode Taluk, Namakkal District on 06.04.2023 between 6 PM to 11 PM by considering the petitioner's representation dated 01.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Veiyappamalai Arulmigu Sree Subramaniya Swamy Temple Panguni Uthiram Car Festival at Tiruchengode Taluk, Namakkal District on 06.04.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 01.02.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 01.02.2023 and pass suitable orders based on the above said circular.
