Prayer: Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Certiorarified Mandamus, calling for the records in the impugned Computer Patta No.2267 dated 18.07.2012 issued by the first respondent for the properties of the petitioner comprised S.F.Nos.75/1A, 75/1B and 75/2 situated in No.43 Padur Village, Chengelpet Taluk, Kancheepuram District in Sale Deed dated 24.10.1994 registered as Document No.2652 of 1994 and quash the same and consequentially direct the first respondent to consider the application of the petitioner dated 09.07.2012 for transfer of patta for the lands comprised S.F.Nos. 75/1A, 75/1B and 75/2 situated in No.43 Padur Village, Chengelpet Taluk, Kancheepuram District in Sale Deed dated 24.10.1994 registered as Document No.2652 of 1994 after affording opportunity of hearing to the petitioner and also if any persons concerned with the lands in accordance with law.

ORDER

The learned Additional Government Pleader, appearing on behalf of the respondents 1 and 2, brought to the notice of this Court that the subject property mentioned in the writ petition has already been gifted to the fourth respondent by the petitioner.

2. In view of the fact that the property has already been gifted, the petitioner cannot seek resumption of the land or otherwise. If at all the appeal filed by the parties is pending before the District Revenue Officer, the petitioner is at liberty to pursue the same. Still any fraudulent registration or otherwise has been done, then the parties have to approach the Competent Civil Court of Law for the purpose of redressal of their grievances.



3. With the abovesaid observations, the writ petition stands disposed of. However, there shall be no order as to costs. Consequently, the connected miscellaneous petitions are closed.
