ORDER

The Writ Petition has been filed to direct the respondent authority to direct the respondent to give permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of "Poomarathur Village Arulmigu Sree Masakthi Mariyamman Temple Festival" at Omalur Taluk, Salem District on 05.03.2023 between 6 PM to 11 PM based on the petitioner's representation dated 03.02.2023.
