ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Arulmigu Sri Muthu Mariamman Temple Festival, Chinna Muthalaippatti Village, Namakkal Taluk, Namakkal District, on 02.03.2023, 06.00.p.m onwards by considering the petitioner's representation dated 06.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Arulmigu Sri Muthu Mariamman Temple Festival, Chinna Muthalaippatti Village, Namakkal Taluk, Namakkal District, on 02.03.2023, the petitioner has sent a representation, dated 06.02.2023 to the respondent Police.
