This case came up for settlement before the National Lok Adalat. Both the parties are present. The learned counsel for the appellant Mr.Ramya V.Rao and the learned counsel for the second respondent Ms.A.Salomi are present. After mutual discussion, negotiation, mediation and conciliation between both parties, they arrived at a compromise to settle the matter as follows:

TERMS OF SETTLEMENT

Both the parties and their respective counsel are present.

2. The Tribunal has awarded a sum of Rs.14,38,436/(Rupees Fourteen Lakhs Thirty Eight Thousand Four Hundred and Thirty Six only) with interest at 7.5% p.a. from the date of petition till the date of deposit as compensation.

3. Aggrieved by the award, the appellants have preferred the present appeal. Now the appellants/claimants have agreed to receive a sum of Rs.8,00,000/- (Rupees Eight Lakhs only) in addition to the amount already awarded by the Tribunal in full quit, which is also acceptable by the second respondent.



4. The second respondent is directed to deposit the award amount, now ordered after deducting any amount already deposited, within a period of six weeks from the date of receipt of a copy of this order. Award is passed accordingly. On such deposit, the claimants are permitted to withdraw the Award amount as per the apportionment given by the Tribunal, after deducting the amount already withdrawn by the claimants, if any. The share of the minors shall be deposited in any Nationalized Bank till the minors attain majority.

5. The Tribunal is directed to issue the award amount through NEFT/RTGS to the party concerned on proper identification in accordance with the terms of the award, without insisting on any formal permission petition.

6. The appeal is ordered accordingly. Consequently, the connected MP, if any, is closed.
