4.Mrs.K.Bhuvaneshwari is present in Court. She informs that she has paid a sum of Rs.20,00,000/- (Rupees twenty lakhs only) to the decree holder Mr.Murugesan who in turn has also executed a sale deed in her favour on 04.08.2023 in Document No.R/ ஆற்காடு/புத்தகம்-1/5712/ 2023.

5.I have gone through the memo of compromise. Since, Mrs.Bhuvaneshwari confirms the payment of Rs.20,00,000/- and execution of the sale deed in her favour, I do not find anything illegal or irregular in the memo of compromise. The same shall form a part of the record.

6.This civil revision petition is disposed of in terms of the compromise. No costs.
