COMMON ORDER

The Additional Chief Secretary to the Government of Tamil Nadu, Revenue and Disaster Management has filed an affidavit pursuant to our dated 23.01.2023. Paragraph 6 and 7 of the said affidavit extracted below:-

“6.It is respectfully submitted that, according to the above proceedings, registration of sale deed was executed with land owners Thiru.Thilagar and Tmt.Vasantha on 19.01.2023 and 20.01.2023 respectively.

7.It is respectfully submitted that the Deputy Chief Manager, MRTS has sent an additional amount of Rs.3,00,00,000/- vide Cheque No.073125 dated 18.01.2023 to the Special Tahsildar (MRTS) on 18.01.2023. The same was deposited into the State Bank of India, Tambaram Branch on 18.01.2023 vide Challan No.20230118009047. The cheque was cleared and amount was deposited into the Special Tahsildar (MRTS) account only on 23.01.2023.”

2.Mr.G.Krishnakumar, learned counsel appearing for the contempt petitioners would submit that entire amount payable as compensation has been credited to the account of the claimants.
