The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the

event of Arulmigu Sri Maga Mariamman Temple Festival, Perungurichi village, Paramathi vellore Taluk, Namakkal District on 22.02.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 07.02.2023.
