ORDER

2. The learned counsel for the contempt petitioner/decreed holder undertakes that he would approach the II Additional District Court, Ranipet, where the execution petition in E.P. No.18 of 2017 was pending for raising the attachment.

So far as the decree debt is concerned, full satisfaction is recorded and the contempt petition is closed. In the eventuality of the contempt petitioner not approaching the II Additional District Court for raising the attachment, it is open to the respondents 5 and 6 herein to approach the same court with the present order for raising the attachment.

3. In fine, the contempt petition is closed. No costs. Consequently, the connected sub application is also closed.
